
## Danard, Don

I have held an owner's licence for more than 20 years and since 2016, I have been a Board member with New Stride Thoroughbred Adoption Society. I have also been a paid BC Racebook social media influencer (follow me @denisepraill) for the past two years, sharing and promoting local and Canadian horse racing news. Recently at auction, I rescued more than 25 vintage Hastings trophies - some dating back to 1987- to preserve our racing history.

In my day job, I am the Chief Development Officer for Canuck Place Children's Hospice, responsible for fundraising more than \$17M in revenue annually. During my eight-year tenure at Canuck Place, I have increased total revenues by 81% and secured annual and end-of-year grant funding from the Province of BC.

I am a values-based leader with passion and talent for forming and engaging strong teams and building effective relationships with donors, government officials, community partners and organizations. I have deep experience developing government relations, corporate partnerships, soliciting gifts and negotiating sponsorship agreements. I believe in cultivating relationships through careful listening, open communication, and transparency. I hope to bring my professional background, skills, and connections forward to rejuvenate and improve our local racing venue and industry for all partners.

We have a terrific live sport that should be viewed a gem in this city.
