#### Neigel, Tara



I have been involved in thoroughbred industry for close to 20 years. My passion grew the more time I spent in racing. I found a sense of community focused around the thoroughbred. The HBPA and Thoroughbred Ladies Club contributed scholarships to my education at Simon Fraser University. I felt the support of the horseman and veterinarians in sharing their profound knowledge and heard their cheers winning my first races. I have also been heavily involved in the sales of retired racehorses to their new careers. Watching OTTB's flourish is as satisfying as crossing the finish line first, one of the greatest feelings.

We are at a turning point in our industry. There has been a slow and steady decline in trainers, owners, breeders, and the horse population to where we are today, but this sport can be revitalized.

First and foremost, we need open lines of communication. Communication between the associations and operators in a positive and forward-thinking manner. As importantly, communication with the horseman is crucial. We can achieve this through weekly HBPA newsletters, an updated and current website with meeting and financial minutes, open online forums, and regularly scheduled meetings.

Secondly, we need to promote our sport. This can be accomplished through several avenues namely advertising, social media, and corporate sponsorship of important races to increase purse value and enhance the venue for spectators and owners. Ticketed events such as the Deighton Cup have also been well received. The HBPA could promote a few ticketed events for revenue and exposure throughout the racing season.

Lastly, we need to build our backstretch.

In addition to a fresh horse program and breeder incentives, we need incentives to bring in new owners to the game. This can be through financial incentives and events that promote horse ownership. It's also crucial that we work towards more racing days and a longer meet. With the racing season becoming shorter and shorter, we have lost exercise riders, grooms, hot walkers,

jockeys, valets, and gate crew. Even with providing accommodations, longer term employment will make the industry more attractive again.

On a final note, we have a few trainers with most of the owners and horses. The small stable has mostly been eradicated. It is the same trainers with multiple horses competing amongst themselves. Incentives could be offered to build the smaller stables. As well, placing Hastings Racing Club horses in smaller barns would help build those small stables and give the clubs greater attention. In addition, various levels of syndicate ownership could be offered congruent with a fresh horse program.

A commonality between everyone at Hastings Racecourse is that we are passionate about our sport and thoroughbreds. To move forward we must bring fresh ideas, positivity, and tenacity. We won't always agree on what's best, but I believe if we are unified in our efforts we will succeed!

# Snow, Mel - incumbent

Mel is an active and experienced multi-generation trainer who has been vocal in his support for horseracing for years. He has worked with the Board with his focus on track conditions and jockey recruitment.
